- Round table introduction & brief updates from organisations attending. Plus guests from MEDIKO (BU) and Ilea Nyokav Goll (NACOT) Apologies from Vince McNeilly (INSHPO) & Richard Habgood (ISHCCO) who were due to be present to the meeting.

5. Events / meetings:

- Each member gave brief details on upcoming events and hot topics for their organisation.

- GB IOSH International Conference, 16-17th June, Excell London (website for full details)
 Any one visiting UK welcome to join IOSH Branch (local network) or Group (Sector / Industry) meetings most are free. Hot Topic: Competency & Leadership in OSH.
- **IE** Irish Conference June. Hot topic: Construction loss of expertise overseas in down turn, now government want them to return.
- RU- 22 / 9 /15 Moscow Conference (Co-organiser) Safety in Coal Mining, Dec.'15 Expo (Moscow) "Biot" NACOT website. Hot Topic: OSH for Social / Healthcare workers psychological risks competence & forecasting risk.
- **BU-** International Companies coming to BU & want international standards, but struggling.
- **PT** 8th WoS Conference23-25th Sept., Porto. "Smart prevention, for sustainable safety" SPOSHO Conference March '16.
- IT Have official ENSHPO 'branded' delegation to A+A. Bologna Expo Oct '16. Hot Topic 'Safety Health & Environmental protection sustainability & social responsibility' have a more 'circular' economy. Also ISSA / ILO safety in education...messages for 'normal' people about health & safety.
- **CY-** 12th to 13th June 'Plant integrity, failures & assessment methodologies' event key note speaker from IOSH. Uni Cyprus & CySHA Fire Safety 16-18th June. 30 31 Oct Health & Hygiene (to send details to Laurence ref NTTL speaker)

5b) ENSHPO Proposals for the next 3 years; Giancarlo Bianchi – presentation.

- **ENSHPO strategic plan** i) Strengthen links to EU-OSHA & get involved with ILO & ISSA meetings (invite to ENSHPO meetings) ii) Pursue becoming a reference body. Iii) Increase number of associations belonging to ENSHPO.
- Meeting agreed need to generate best practice at EU level. Training from school to universities using same "language" & methodology. More joint projects like EU – Safe.
- ENSHPO sent suggestions to EU OSHA as they reviewed strategy. Re-circulate to members Action: GC / Secretariat. Invite SLEK to next meeting to speak on strategy / plans / activities. Action: EC / Secretariat.

Bruce Phillips – Round Table debate: Important we consider how we communicate with members, potential members & stakeholders.

- Need a consistent communication plan. What should be ENSHPO's priority? Agreed:
- 1) Achieve broader representation BEFORE building ENSHPO visibility cover <u>all</u> 28 EU countries (not just 16) prioritise large countries + E. Europe
- 2) Articulate the value of professional standards (to end users) ... EU Safe integrate environment with H&S. Each member to network contacts relating to environmental aspects. Summary of feedback & ideas attached (Fig 2) Action: Secretariat to condense feedback & ideas & circulate to all Action: All members to review Fig 2 and commit to a plan and report back. Not just EC responsibility to define Communication Plan & action plans.

6. Working with partners

- **EFIP** European Federation of Independent Professionals (Independent OSH Practitioners & Consultants. EC want to work more closely with them. Flag meetings & share meetings /minutes.
- **INSHPO** continue dialogue & invite Vince McNeilly to next meeting / Confirm A+A involvement **Action**: Secretariat / Ralf Giercke.
- ISHCCO continue dialogue & invite Richard Hadgood to next meeting. Action : secretariat

7. Safety Card Project – Claudio Munforti (CM)

- Comprehensive update presented to the meeting. 2010 many work force & supervisors had safety cards. Hoped to harmonise under ENSHPO safety card. Draft standard presented poor participation (crowded market)
- 3 pilots each with different expectation (not appropriate for UK oversubscribed)
 Conclusion: i) Northern Countries some success e.g. FIN
 - ii) GER looked at adoption by larger companies, but now stalled
 - iii) ITA encountered difficulty.

Some interest from BU & RO. No USP – look at collaborating with existing schemes. Need to consult with end users – consider trial with Naval Building or Construction on a common European basis. Doytchin Doytchev – safety card survey results to be provided **Action**: CM More information needed from members to progress project.

8. <u>EuroSHM Certification</u> – presentation, Claudio Munforti (CM)

- CM provided detailed presentation on back ground to certification committee, activities & processes. European wide harmonised standard 2 levels i) EuroSHM ii) EuroTech. Some schemes auto accepted (opting out countries .e.g. UK, ITA, RU, do local review & evaluation) Others use certification committee. Broader representation on committee provided by Athos (CY) but need more e.g. FR & Scandinavia.
- Recognise need review profile & requirements (in line with EU Safe) also need to refurbish standard (GC) to include i) Soft skills e.g. Leadership ii) Environment – broadening competence base. Based on EQF criteria – (knowledge, skill, competence) i.e. ability to solve real life business OSH situation.
- Any members wanting to get involved with EuroSHM to contact CM (could be as an individual, or to get country scheme accepted) Action: CM to send grid of countries with national validation to Secretariat / BP. Marina (CY) would like national scheme certified.
 Action: CM / MK (CY)
- **Action**: All ENSHPO members to contact end users & education providers to make sure they provide something that can meet the standard.
- Reality Check: EuroSHM / EuroTech standards are struggling numbers are very low & realistically (currently) not viable going forward. Schemes should be reconfirmed & audited every 3 years this needs to be urgently done. As an organisation are ENSHPO prepared to put the time & resources in to turn EuroSHM / Tech around?
 Action: All members to confirm i) Are members getting value from the scheme? ii) Are they in favour of continuing the scheme? by next full meeting (Secretariat to collate feedback.
- 9. <u>ENETOSH presented by Dmitry Platygin</u> Director General All Russian Institute for Occupational Safety & Hygiene.
 - Excellent presentation concise summary of development of new ENETOSH strategy & action plans. Clear relevance to ENSHPO lots of synergy and opportunities for ENETOSH to work together & share information.
 - ENETOSH web platform is key to their distribution of information very powerful tool. **Action:** Secretariat to request copy of Presentation from Dmitry Platygin (ENETOSH)
